TDG REWARDS

With TDG Rewards, every qualifying sale puts money in your pocket. Rewards are paid weekly on a bank-issued debit card, making it easy to earn and enjoy the benefits of selling The Dixie Group's trusted brands.

TDG Rewards

All active participants will earn standard rewards rates and regular promotional rates.

TDG Rewards Plus

Once a participant reaches \$1000 in standard rewards earnings¹ in a calendar year (Jan 1- Dec 31) they will earn an additional 25% bonus (1.25X) on standard rewards and promotional rates for the remainder of the calendar year. Tier status will start back at dollar one on January 1 of each year.

¹ Special Promotional rewards such as 2X rewards are not included as qualifying earnings for tier status. All minimum requirements are based solely on base standard qualifying reward rates.

Program Outline

Terms & Conditions:

1. No retroactive rewards will be issued. Participants MUST be enrolled and opted in to TDG Rewards at the time the order is placed in order to receive rewards.
2. Enrollee MUST opt in and complete registration with 90 days of enrollment or all earned rewards will be forfeited and participant must re-enroll.
3. No reversal of issued funds to incorrect participant after order has shipped unless the error is found to be of TDG fault.
4. All EDI Orders must contain recipient name at time of order to be credited with sale. Or corresponding email communication must be sent to program administrators before order has shipped for credit to be applied.
5. All orders must be assigned within 30 days of order entry to receive rewards, failure to do so will result in forfeiture of rewards earned.

Tax Information:

TDG Rewards is designed to be an individual RSA rewards program and meant to be rewarded to the individual RSA. All earned rewards over \$600 annually are subject to income tax and must therefore be rewarded directly to individuals who have opted-in, supplying the required legal information for IRS reporting. Any misuse or pooling of sales will result in disqualification of advanced tiers of TDG Rewards Plus.²

Standard pricing restrictions apply:

- All orders must meet minimum required pricing to qualify for rewards. Any special or reduced priced orders dropping below minimum pricing are excluded from TDG Rewards.³
- A detailed list of the minimum qualifying price by product will be available from your TDG Territory Manager.
